Waiver

Terms and Conditions

1. The player understands and agrees that the sport of hockey has inherent physical dangers that may result in serious injury and/or death. The player understands that there may be risks connected with the sport of ice hockey that are not known to the Edmonton Recreational Hockey League, hereafter referred to as 'the League'. Nevertheless, the player assumes all personal injury that may result from participation in activities of the League. The player will not hold any of the League's officials, management, owners, nor the proprietor or employees of any ice facility used by the League liable for injury, which the player may sustain while participating in any league activity.
2. The player certifies that he/she has reached the age of majority (18) and has medical insurance that would apply to any sport-related injury. The player understands and agrees that he/she is responsible for any and all medical costs arising from any injuries while participating in any league activities
3. The player certifies that he/she has no known medical conditions that would prohibit him/her from participating in the sport of ice hockey. The League strongly recommends each player receive a medical check-up prior to participating in any event.
4. For reasons of safety, the League strongly recommends that all players, regardless of their skill and experience level, wear a league-approved full-facial mask. The League cannot attest to the amount of protection afforded by any method of facial dental protection. The player assumes all risk of personal injury that may arise while participating in the League with any facial/dental protection. The player will not hold the League, any of the League's officials, management, owners, nor the proprietors or employees of any ice facility used by the league liable for any injury which may occur to the player while using any method of facial/dental protection.
5. The player agrees to wear a League-approved protective helmet and facial mask at all times that he/she is on an ice surface during any league activity. This shall include, but is not limited to warm-ups, school, breaks in games, and all times when directed to do so by a League or on-ice official. The player understands and agrees that he/she will be subject to suspension and/or expulsion from the League for violation of this rule. Players who are goalkeepers agree to wear a League-approved helmet and cage combination at all times he/she is on an ice surface during any league activity. This shall include, but is not limited to warm-ups, school, breaks in games, and all times when directed to do so by a League or on-ice official.
6. The League does not warrant the quality of any equipment used in any League activity. The player understands and agrees that in the event that he/she sustains an injury as a result of a defect present in any equipment, he/she will not seek redress from the League.
7. The player agrees to comply with colour co-ordination requirements (i.e. matching pants & helmet colour). A player agrees to comply with colour coordination requirements upon the delivery of their official League jersey. It shall be the sole responsibility of the player to obtain colour coordinated pants & helmet.

8. The player agrees that he/she will act in a mature and responsible manner in all League activities. The player understands that, as a member of the League, he represents the League to the general public. The player understands and agrees that any behaviour that the management deems to jeopardize the League's ability to lease ice or otherwise conduct its' business will result in the player's immediate expulsion. The player further represents that he/she has never been expelled or barred from registering with any adult hockey organization for reasons of violence or other misconduct.
9. The player agrees to reimburse the League in full, within ten days of notice, for the cost of any property damage for which the player is held responsible by the management of the league.
10. The player understands and agrees he/she may be expelled from the League for any of the following reasons:
 - a) failure to abide by all the League rules and directives.
 - b) falsification of registration information.
 - c) receiving two game misconduct penalties within a period of twelve calendar months.
 - d) receiving one game misconduct penalty and one match penalty within a period of twelve calendar months.
 - e) receiving two match penalties within a period of twelve calendar months.
 - f) excessive penalty minutes within a period of twelve calendar months.
11. Prior to commencement of use by a player of the facilities selected by the League, each player will sign a duly executed waiver that hereby will remise, release, discharge, waive, indemnify and save harmless the Knights of Columbus Hockey, or any other ice facility from any and all liability, costs (including without limitation legal costs), claims damages, demands, actions and causes of action at law and/or equity arising as a result of any loss, damage, personal injury or death suffered by a user attending the rink to participate in ice hockey, including without limitation, negligence on the part of the Knights of Columbus, save and except for latent defects to the rink boards, rink glass, structure of the building itself, not including the ice at the K of C Twin Arenas or any other ice facility.
12. The player agrees the terms 'E.R.H.L., 'Edmonton Recreational Hockey League' are exclusive property of the League and shall not be used in any manner in connection with any non-league play or any tournaments or multiple games events that have not been expressly approved or endorsed by the League.
13. Any players, coaches, captains, etc. will be held accountable for their actions to referees, administration and other players. Any objectionable conduct can result in suspension by the administration.
14. The player acknowledges that he/she has received, has read, and understands all the provisions of these Player Registration Terms, and the player agrees to be bound by and comply with all other provisions issued by the League.
15. The player understands and agrees the above terms represent the entire agreement. There are no valid or binding representations, inducements, promises or agreements, oral or otherwise between the player and the league not contained within.
16. The player agrees to all these terms for all league activities.

The player hereby acknowledges, having read the foregoing and acknowledges he/she fully understands it.
